A Message from Your Chair

by Richard L. Ross



I have finished my first two-year term as your chairman and have now commenced my second and final term. My two-fold goal is to increase membership in our organization and to increase our influence with OPERS and the Ohio legislature. Without your support, the organization has no influence. We represent about eighteen (18) per cent of the 200,000

OPERS beneficiaries. At one time we represented about thirty per cent of OPERS retirees. COVID and an increasing reluctance in our society to join organizations have decreased our numbers. Please reach out to your former co-workers and ask them to join us in our mission to preserve our pensions and benefits.

H.R. 82, the US House bill to repeal the WEP and GPO, has 298 co-sponsors, including 11 of Ohio's 15 representatives. S.B. 597, the WEP and GPO repeal bill in the US Senate, has 47 co-sponsors, including both of Ohio's senators. It would appear that passage, if it happens, would first happen in the House. H.R. 6, a resolution in the Ohio House urging the Ohio congressional delegation to join in repealing WEP and GPO, was passed unanimously by the Ohio House Pension Committee.

We had an excellent annual meeting last month with almost 300 attendees. The food was good, the speakers interesting, and the break-out sessions informational. Please mark your calendar to attend next year to celebrate our 50th anniversary defending our defined benefit pension system, the best in the country.

I enjoy meeting our members and learning your concerns. At the state meeting, I met two PERI members who had worked in Lucas County but had retired to "that state up north". A couple who recently returned to Southeastern Ohio, after living for several years in Florida, told me of a group of our members that meet in Central Florida. I may have to make a January trip to visit that chapter! Seriously, I enjoy going to chapters to speak and listen. If any of you chapter officers feel that a visit by an officer or our executive director will be of benefit to your chapter, contact us. I have been at the Morgan, Perry, and Tuscarawas County chapters recently.

Finally, I would like to thank Jim Douglas and John Haught for the service that they have rendered to PERI. Both have left the board in the last two months. Their wisdom and counsel will be missed.

Legislative Report

Greetings, PERI Members:

I hope this newsletter finds you in good health and high spirits. As your government affairs team at the Ohio Statehouse, we are committed to informing you about the latest public policy developments and the Ohio

political landscape. This letter highlights key updates regarding the Ohio Retirement Study Council (ORSC), Ohio House Pensions Committee changes, and Federal WEP/GPO legislation - The Social Security Fairness Act 2023 (H.R. 82/S.B. 597).

Ohio Retirement Study Council (ORSC)

We continue to monitor all scheduled Ohio Retirement Study Council hearings. Most recently, members of ORSC were presented with a 2022 investment performance presentation by RVK CEO Becky Gratsinger. The returns for Ohio plans varied from 0.12% to 1.96% in the last two quarters of 2022. Gratsinger stated that equity and fixed-income markets exhibited better outcomes in the fourth quarter despite increased volatility, which was a challenging year for many investors.

The ORSC continues to play a vital role in shaping retirement policies that directly impact public employees across our state. Through its research, analysis, and recommendations, the council strives to ensure sustainable retirement benefits for all public employees while considering fiscal responsibility. We actively engage with ORSC members to advocate for fair and equitable retirement policies that protect our members' interests.

The next ORSC meeting is tentatively scheduled for Thursday, November 9, 2023.

The Ohio House Pensions Committee Welcomes New Chairman

In other related news, Speaker Jason Stephens has named freshman Representative Adam Mathews as Chairman of the Ohio House Pensions Committee following the ongoing legal troubles and subsequent resignation of former Committee Chairman Bob Young. Chairman Mathews is serving his first term in the Ohio House of Representatives, representing the 56th Ohio House District. This district includes Lebanon, South Lebanon, and Mason, covering a southwestern portion and central Warren County.

Prior to his political career, Rep. Mathews worked as a civilian engineer for the Naval Nuclear Propulsion Program. He later pursued a career as an intellectual property attorney after returning to Notre Dame. In his legal practice, he represents inventors, small businesses, and entrepreneurs. Rep. Mathews also has experience in local government, as he previously served as the Vice Mayor of Lebanon before being elected to the Ohio House of Representatives.

The Ohio House Pensions Committee is a crucial platform for discussing pension-related legislation affecting public employees' retirement benefits. We closely monitor committee activities to provide input on proposed bills that could impact our members' financial security during their well-deserved retirement years.

Federal: Windfall Elimination Provision & Government Pension Offset

At the Federal level, we have further bipartisan progress as it relates to U.S. Senator Sherrod Brown's (D-Ohio) version of the Social Security Fairness Act 2023 (S.B. 597) – with the recent co-sponsorship of Ohio's Republican U.S. Senator, J.D. Vance. At the time of this writing, the Senate legislation has 47 co-sponsors, including 37 Democrats, 7 Republicans, and 3 Independents. The House version, H.R. 82, has secured 298 cosponsors, including 11 of Ohio's 15 Congressional members.

The Social Security Fairness Act 2023 (HR 82) addresses concerns related to the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO), which have long affected public employees' Social Security benefits. We are actively monitoring the progress of this legislation at the federal level and collaborating with national advocacy groups to support its passage. We aim to rectify these unfair provisions, ensuring our members receive their full Social Security benefits earned through other employment.

The 49th Annual Meeting

Lastly, here is a quick note on PERI's recent success in hosting members at the 49th Annual Meeting. I'd like to sincerely thank OPERS Director Karen Carraher for her informative presentation on current OPERS initiatives and legislative priorities ahead. We were also honored to have Representatives Rodney Creech and Mary Lightbody join us as keynote speakers, advocating for retirees' rights and discussing legislative initiatives impacting your benefits before the Ohio House Pensions Committee and Ohio Retirement Study Council.

Your active participation, insightful questions, and unwavering support strengthen our collective voice as we advocate for fair policies safeguarding your hard-earned benefits.

I encourage you to stay engaged by attending future events, sharing concerns or suggestions directly with PERI, and participating in grassroots advocacy efforts protecting retiree interests across Ohio. Thank you for your ongoing support as we work together to protect and enhance retirement benefits for all public employees in Ohio.

We are the only association that is focused exclusively on OPERS' pension and benefits and always advocate on behalf of the retiree.

Protecting Yourself from Marketing Violations

During Medicare's Open Enrollment Period, you will likely experience more marketing from private Medicare plans, like Medicare Advantage Plans and Part D plans. Companies try to reach consumers in various ways, like television commercials, radio ads, events, mailings, phone calls, and texts. The government has rules, though, to protect you from forceful or misleading marketing. Knowing the rules and red flags can help you make the best choices for yourself during Open Enrollment.

Remember, these companies are not the government. They just have permission from the government to sell their private plans to you. The government says that plans and their representatives **cannot**:

- Call or email you if you are not enrolled in the company's plan.
- Call or email you if you have asked them to stop even if you are enrolled in their plan.
- Visit your home without an appointment.
- Sell you a plan or set up a sales appointment with you while at an educational event. If you share your contact information at an event like this, this often permits plans to contact you later. However, this permission to contact you expires after 12 months.
- Use the Medicare name or logo or imply that they represent Medicare.
- Approach you in public spaces like a mall or parking lot.

On the other hand, plans and representatives **must**:

- Explain how enrolling in a new plan will affect your current coverage.
- Check that your providers and pharmacies are in the plan's network before enrolling you.
- Tell you which companies they represent and whether they sell all plans available in your area.
- Schedule an appointment with you no sooner than 48 hours after you agree to the scope of the appointment.

You may not remember all the rules, but there are some definite red flags to watch out for. For example:

- No one should make you feel pressured or rushed to enroll in their plan.
- No one should make you feel that you could lose your Medicare benefits if you don't enroll in their plan.

- No one should ask for your Medicare or Social Security numbers just to provide you with information.
- No one should make a cold call to ask for your Medicare or Social Security information.

Instead, rely on government websites, phone numbers, and offices for information. OSHIIP is a great resource to help you understand these plans. Contact OSHIIP Monday-Friday, 7:30a-5p at 1-800-686-1678.

If you think you have experienced marketing violations, you should report it. Keep any documented proof, such as an agent's business card, marketing materials, emails, or phone call records. You can report marketing violations to OSHIIP at 1-800-686-1578.

No one should ask for your Medicare number, Social Security number, or bank information just to provide you with information. Someone can use your personal information to enroll you in a plan without your permission or to steal your personal information. If you have been enrolled in a plan without your knowledge or because of misleading marketing, you may be able to make changes to your coverage outside of the Open Enrollment Period. Call OSHIIP – 1-800-686-1578 - to see if you qualify and for help making the change.

PERI 2023 Annual Meeting Minutes



Jim Range, District 9 Representative, led the assembly in prayer.

John DiPietro gave opening remarks and introduced OPERS Executive Director, Karen Carraher.

Ms. Carraher discussed pension funding and health care, investment history,

with 2023 preliminary results, and current legislation.

OPERS' overall goals are to provide a stable pension for all OPERS retirees, to provide a meaningful retiree health care program, to minimize drastic plan design changes, to be financially positioned to react to market volatility and to maintain intergenerational equality.



Mr. DiPietro introduced John Franciscan, from OPERS, who presented an educational program entitled "Open Enrollment 2024 and your HRA".

Mr. Franciscan discussed evaluating your medical coverage, OPERS Dental and Vision Plans and choosing a plan outside of Metlife. He provided details about how to

go about making changes in insurance and gave contact information.

Mr. Franciscan ended the program with information about working with VIA Benefits and he reviewed the basics of getting reimbursements from your HRA.

The assembly broke up into a 45-minute breakout session. Each participant had the option to sign up for one out of four different presentations.

The presenters were Jon Green from AMBA on increasing participation and membership growth, David Painter from OSHIIP on Medicare 101, Richard Ross and Greg Bennett on Legislative Networking and Ryan Lippe from the Attorney General's office, on Senior Scams.

The attendees reassembled in the Ballroom for lunch.

During lunch, the Education Committee raffled off a basket from each of the eleven PERI districts filled with items from each county within the districts.



Mr. DiPietro introduced State Representative Mary lightbody, a member of the Pension Committee, to speak to the assembly. Mary has been working on issues such as our sources of energy, aging infrastructure, workforce development, the opioid addiction crisis and other health issues, threats to the environment and

clean water, challenges facing farmers, and the pressures of growth.



Mr. DiPietro introduced Representative Rodney Creech, Chairman of the House Agriculture Committee, to the attendees. Representative Creech is focused on providing high quality education, growing Ohio's economy, job growth, and wage increases, and to fight over regulation and

excessive taxes. Addressing the opioid epidemic is also a top priority.

Chairman Ross presented his report to the assembly. Mr. Ross discussed the need to increase membership, making a plea to members to reach out to former coworkers and acquaintances to let them know about PERI. He said that the only time he carries weight with Ohio

legislators is when he speaks for PERI members. The more members we have, the more weight we carry with the legislators on important retiree issues.

Mr. Ross reported that he testified for HCR 6, urging our Ohio legislators to support federal bill HR 82, the Social Security Fairness Act of 2023.



The bill passed. He shared that we also support Ohio SB 6, the ESG bill that simply codifies fiduciary responsibility of state pension systems prohibiting them from investing for reasons other than returns and benefits.

Mr. Ross shared that he, as well as our other officers, are willing to speak at chapters to help bring more members



to the meetings or address the needs of the chapters.

Treasurer DiPietro presented the 2022 Financial Report.

He reviewed our assets and liabilities, including our investments and annuities.
